NOTE CONCERNING CORRECTION: This Correction Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions is being filed for record to correct certain incorrect information and to substitute for the Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions as originally recorded in Volume 12600, Page 290 of the Official Records of Brazos County, Texas. The following incorrect information is being corrected: *the legal description of Tract Four of the Property contained in Exhibit "A". When this Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions was first recorded, the legal description for Tract Four contained in Exhibit "A" incorrectly omitted the final paragraph of the description of Tract Four.* The Declarant has executed this Correction Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions and acknowledges that the legal description of Tract Four of the Property in Exhibit "A" attached to this Correction Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions should have been included in the original Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions. Other than the stated correction, no changes were made in the Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions as originally recorded, and the effective date of this Correction Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions relates back to the effective date of the Eighth Amendment to Declaration of Covenants, Conditions, and Restrictions for The Traditions being corrected, March 24, 2015.

THIS EIGHTH AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE TRADITIONS ("Amendment") is made this ___ day of _____, 2015, by BRYAN/TRADITIONS, LP, a Texas limited partnership ("Declarant").

WITNESSETH:

WHEREAS, Declarant recorded a Declaration of Covenants, Conditions, and Restrictions For The Traditions on March 3, 2004, in the Official Records of Brazos County, Texas, at Volume 5901, Page 1; and on July 12, 2006, Declarant recorded a First Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions, in the Official Records of Brazos County, Texas, at Volume 7444, Page 49 ("First Amendment"); and on May 12, 2008, Declarant recorded a Second Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions ("Second Amendment"), in the Official Records of Brazos County, Texas, at Volume 8586, Page 52; and on May 3, 2012, Declarant recorded a Third Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions, in the Official Records of Brazos County, Texas, at Volume 10681, Page 73 and then on October 23, 2012, a restated Third Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions ("Third Amendment"), in the Official Records of Brazos County, Texas, at Volume 10973, Page 109; on February 5, 2013, Declarant recorded a Fourth Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions ("Fourth Amendment"), in the Official Records of Brazos County, Texas, at Volume 11151, Page 39; on April 29, 2013, Declarant recorded a Fifth Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions ("Fifth Amendment"), in the Official Records of Brazos County, Texas, at Volume 11312, Page 280, as corrected by Correction Affidavit dated June 3, 2013 and recorded at Volume 11382, Page 180 in the Official

Records of Brazos County, Texas; on August 29, 2013, Declarant recorded a Sixth Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions ("Sixth Amendment"), in the Official Records of Brazos County, Texas, at Volume 11601, Page 219; and on February 27, 2015, Declarant recorded a Seventh Amendment to Declaration of Covenants, Conditions, and Restrictions For The Traditions ("Seventh Amendment"), in the Official Records of Brazos County, Texas, at Volume 12547, Page 281 (collectively, as amended now or in the future, the "Declaration"), such Declaration further identified in Management Certificate of the Traditions Homeowners Association, Inc., in the Official Records of Brazos County, Texas, at Volume 9318, Page 101;

WHEREAS, all capitalized terms used herein that are not otherwise defined shall have the meaning given those words in the Declaration;

WHEREAS, the Declaration identifies and defines the Initial Property and the Additional Property;

WHEREAS, Declarant desires to amend the Declaration for the purpose of submitting a portion of the Additional Property to the Initial Property and adding such portion of the Additional Property to the Community, pursuant to Paragraph 2.02 of the Declaration, such new tracts consisting of four (4) tracts of land in Brazos County, Texas as more particularly described by metes and bounds as set forth on Exhibit "A" attached hereto, such new tracts being called herein the "**Mahogany Drive Neighborhood**"; and

WHEREAS, Bryan/Traditions, LP, a Texas limited partnership, is the owner and developer of the Mahogany Drive Neighborhood;

WHEREAS, Declarant further desires to amend the Declaration for the purpose of amending and restating Section 9.07 of the Declaration; and

WHEREAS, Article XIII of the Declaration authorizes the Declarant to amend the Declaration for the purposes herein described;

NOW, THEREFORE, Declarant hereby amends the Declaration as set forth below.

1. **Definition of Initial Property and Addition of Property to the Community.** The Initial Property, as defined in the Declaration and further described on Exhibit "A" to the Declaration is amended so that the Mahogany Drive Neighborhood is included in the definition of Initial Property, and the Mahogany Drive Neighborhood is submitted to the Property and added to the Community.
2. **Benefitted Neighborhood.** Pursuant to Section 1.01(g) and Section 1.01(gg) of the Declaration the Mahogany Drive Neighborhood is hereby designated as a separate Benefitted Neighborhood within the Community. The Mahogany Drive Neighborhood will not be subject to a separate Neighborhood Declaration, and the Mahogany Drive Neighborhood will not be governed by a separate Neighborhood Association.
3. **Limited Common Areas.** Exclusive of the Lots in the Mahogany Drive Neighborhood, the real property including any improvements, amenities, roads, fixtures and facilities thereon which are located within the boundaries of the Mahogany Drive Neighborhood, are hereby expressly designated as Limited Common Areas of Mahogany Drive Neighborhood, and the access to and use thereof is limited to and for the primary, exclusive use and enjoyment in common by the Owners of the Lots in Mahogany Drive Neighborhood, and to the family, tenants, agents, guests or invitees of each such Owner.

4. **Section 9.07 of the Declaration is hereby amended and replaced in its entirety as follows:**

“9.07 Neighborhood Expenses and Assessments. The Board, in its sole discretion, may determine that certain expenses exclusively and directly benefit some but not all of the Neighborhoods ("**Neighborhood Expenses**"), in which event the Board may ratably allocate those Neighborhood Expenses only among the Lots in the particular Neighborhood(s) that the Board determines are directly benefited thereby. Neighborhood Expenses shall be ratably assessed as separate Neighborhood Assessments to all Owners of Lots in the particular Neighborhood(s) benefited by such Neighborhood Expenses, in the same manner as provided in Section 9.03 and subject to the limitations set forth therein.

Neighborhood Expenses shall include but are not limited to the following: (a) expenses incurred for maintenance and repair of exclusive Common Areas within the Neighborhood; (b) expenses incurred for maintenance and repair of landscaping, landscaped areas, walks, trails, lakes, ponds, fountains, lighting, signage, mailboxes and other improvements situated within the Limited Common Areas of the Neighborhood; (c) expenses incurred for the maintenance and repair of private streets, roads, alleys and sidewalks within the Neighborhood; (d) expenses incurred for maintenance and repair of drainage systems, utility lines, pipes, plumbing, wires, conduits and related systems which are a part of the Limited Common Areas of the Neighborhood and which are not maintained by a public authority, public or private utility, or other Person; and (e) expenses incurred for maintenance and repair of restricted access gates, devices or systems.”


5. **No Other Changes.** Except as amended herein, the Declaration remains in full force and effect.

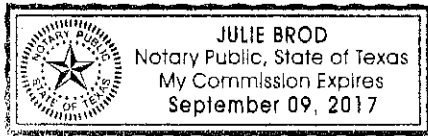
